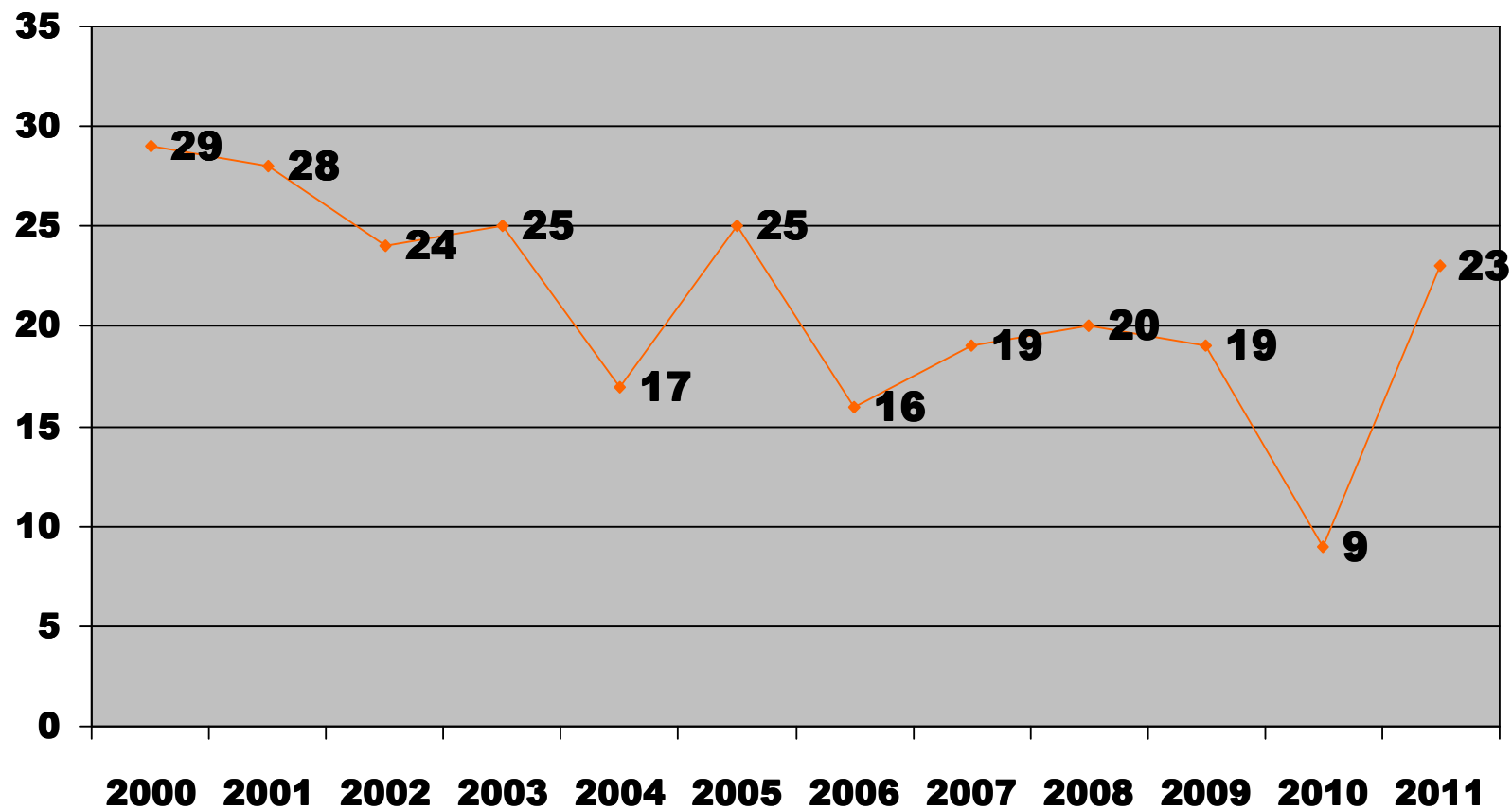

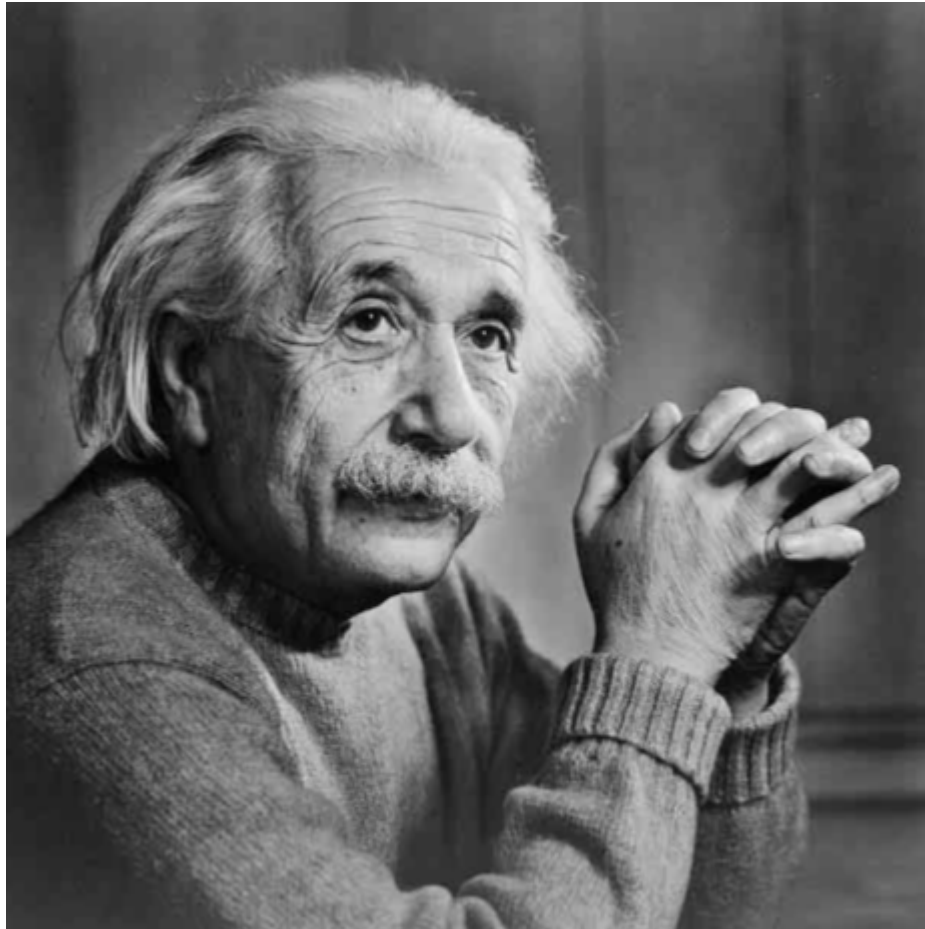


An Alarming Statistic:

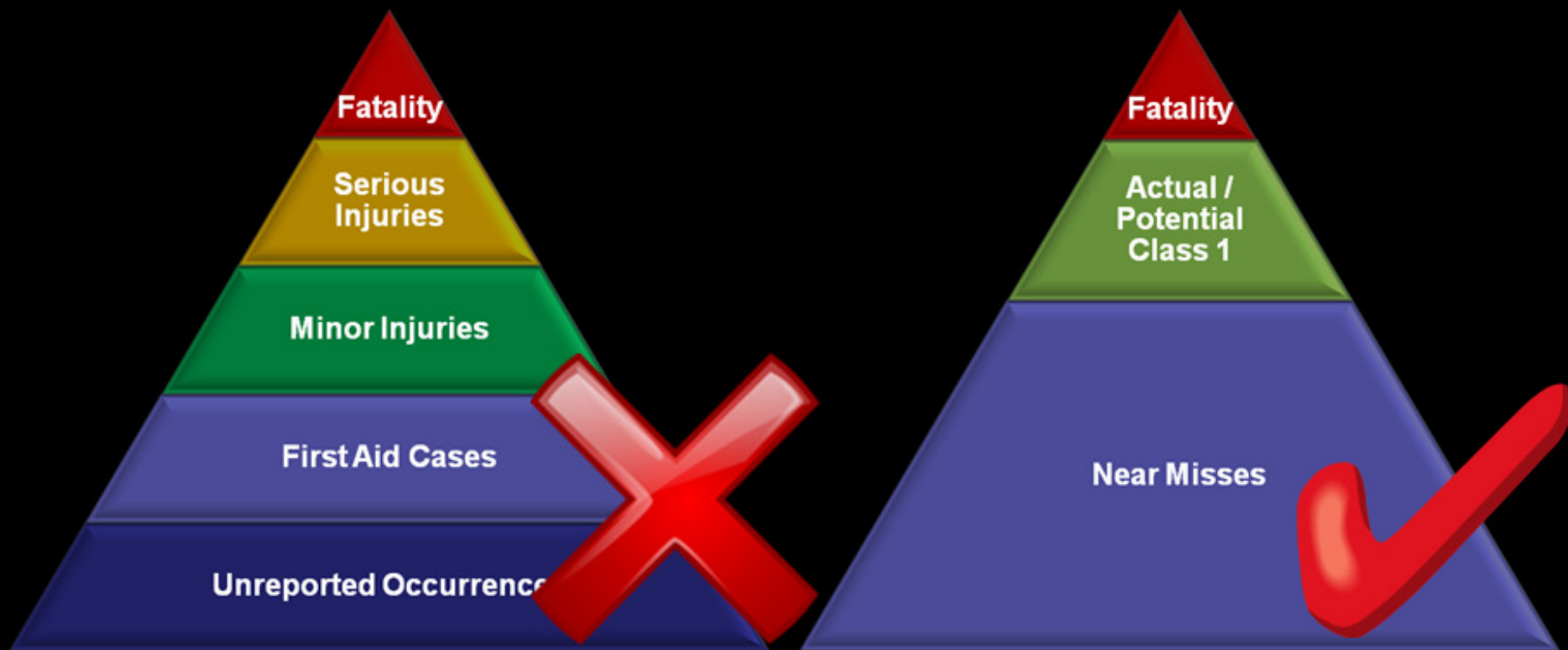


Understanding Our Issues:

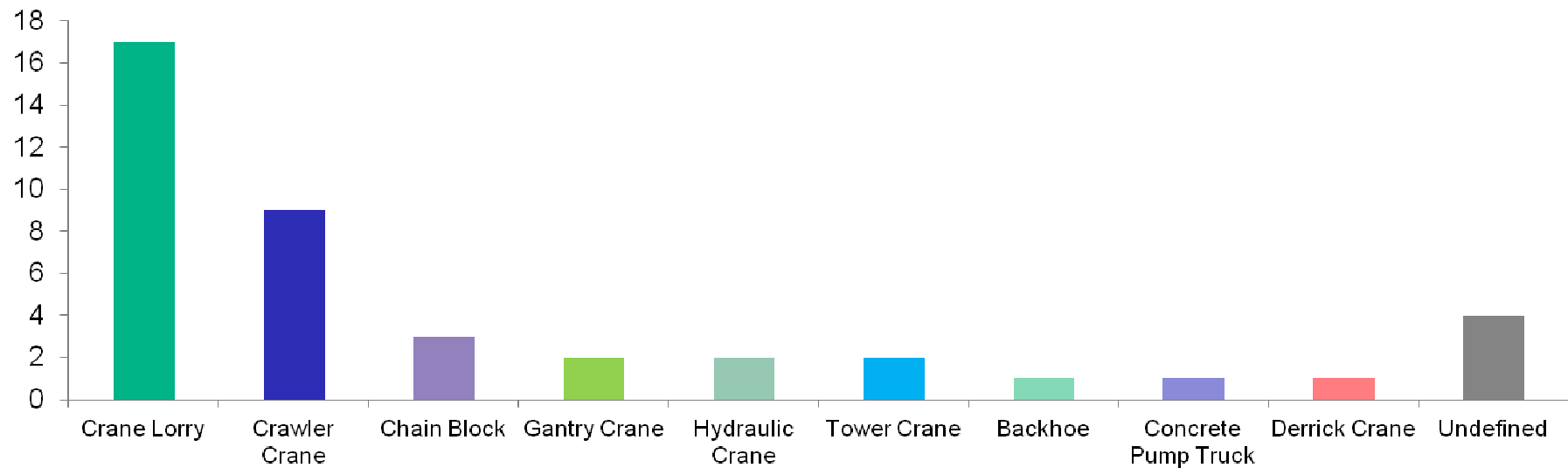


We need to determine immediate causes:

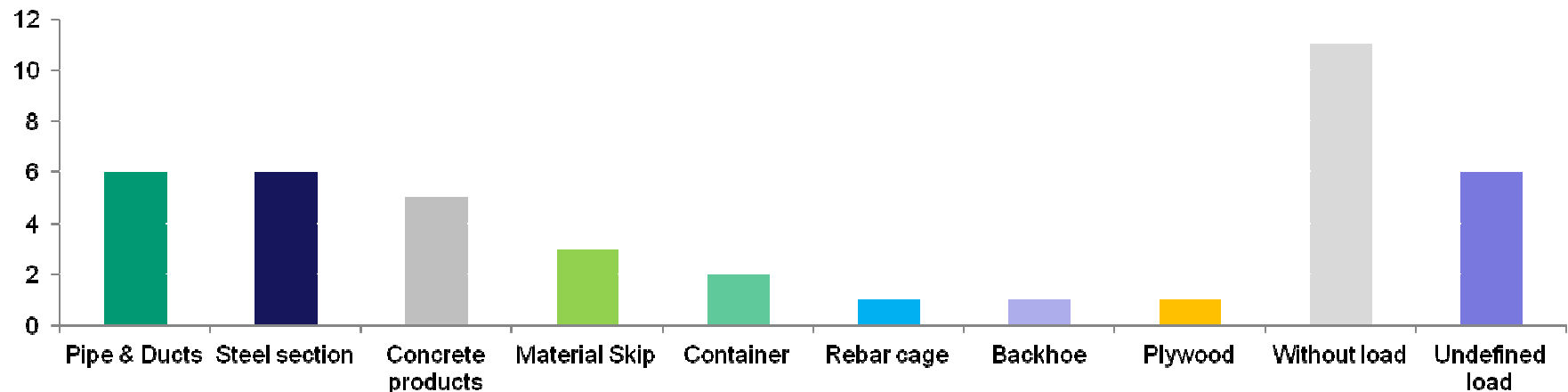

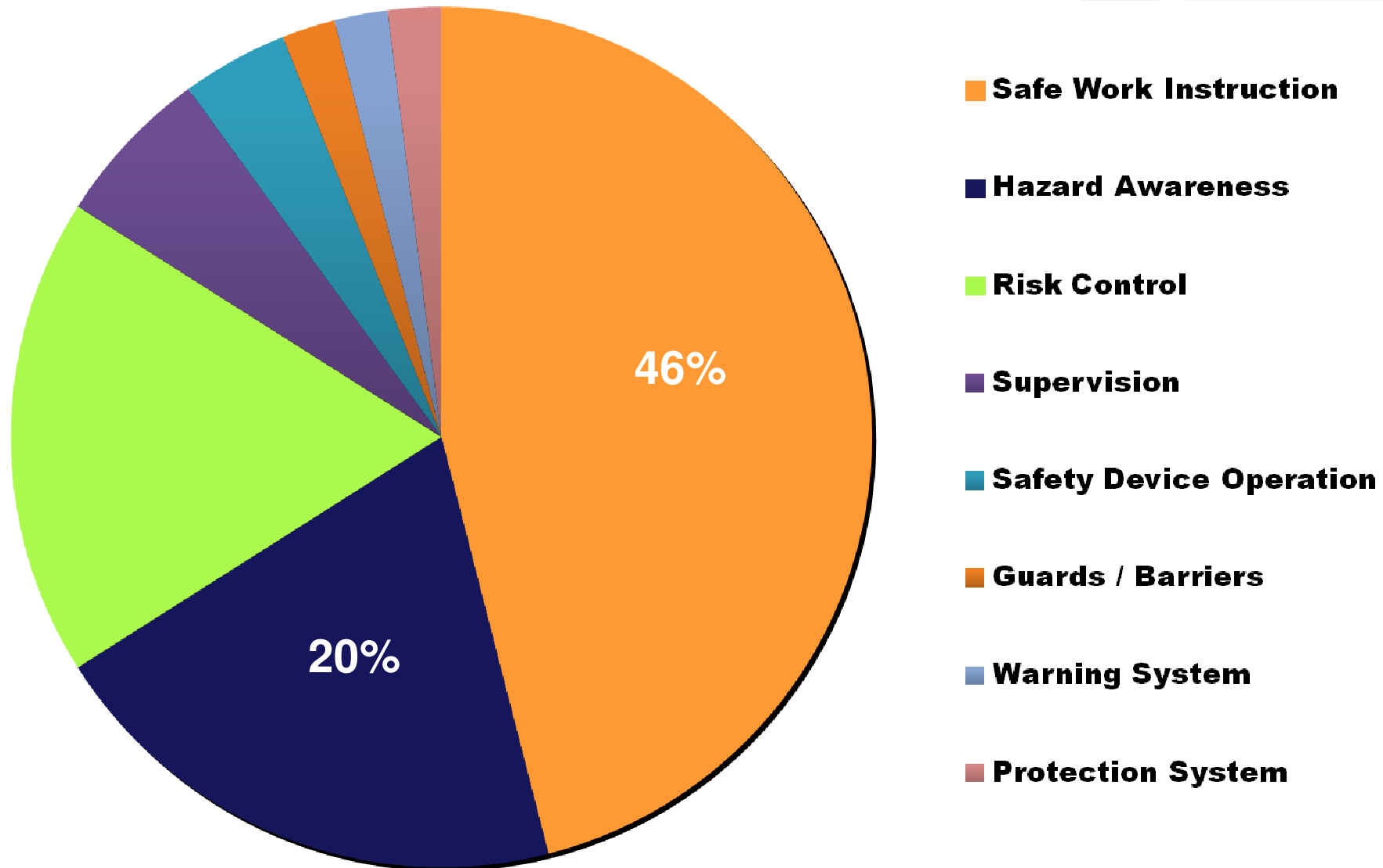

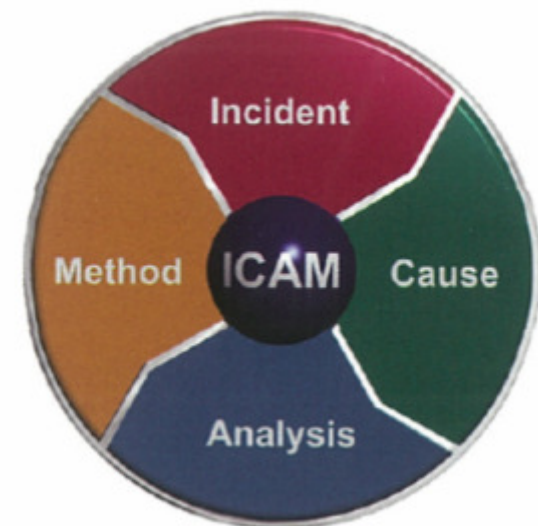
And we must determine Root Causes:

Strategic Changes Made at Leighton



- Safety Harnesses are not to be a primary means of protection

- All new crane trucks have load indicators linked to outriggers extension
- Crane trucks are to be used only to pick up and carry.

- FROP provided for lifts on boom jumbos.





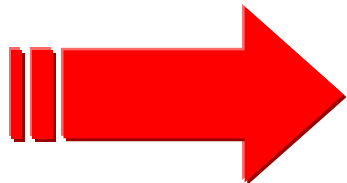
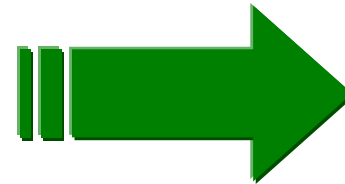

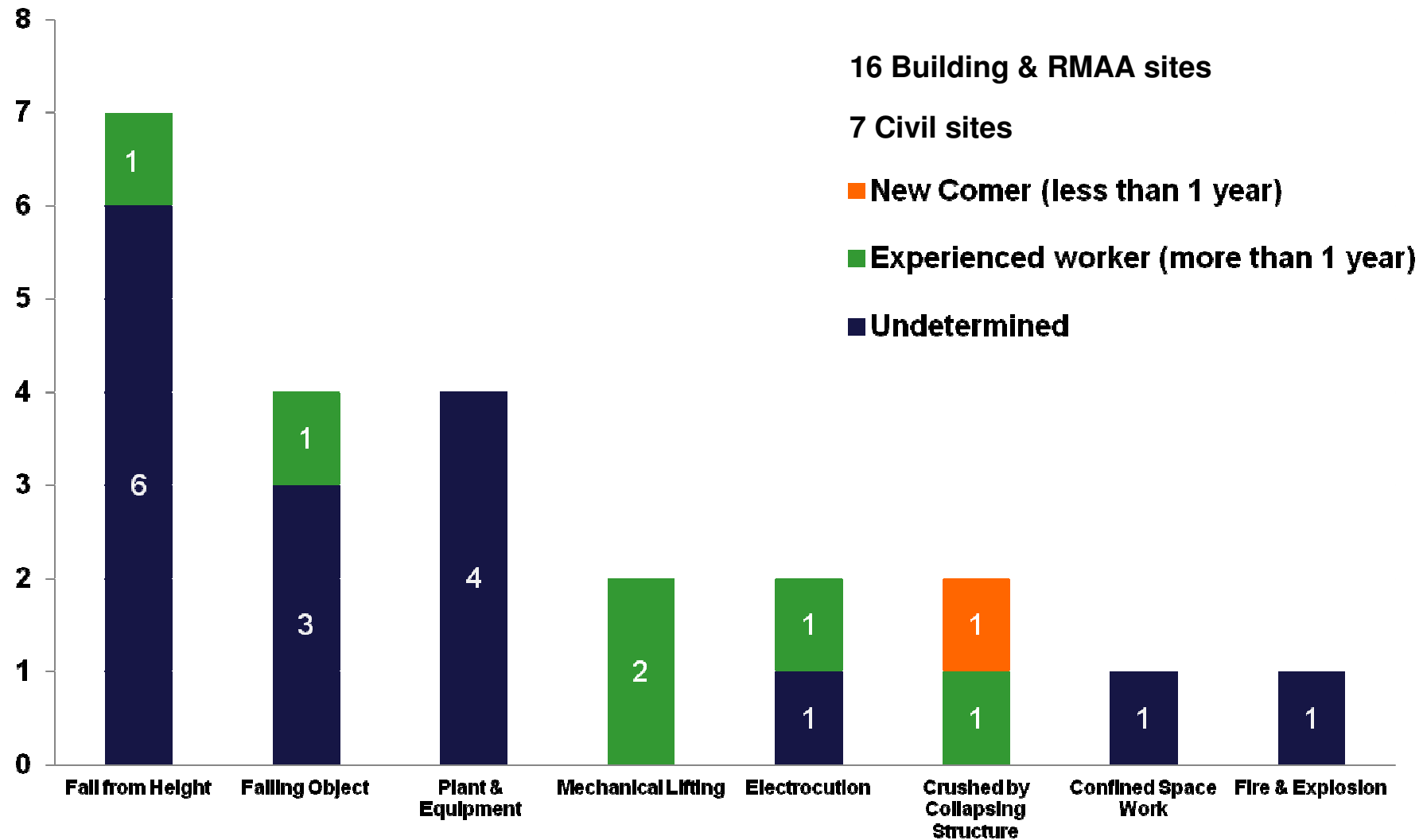
